RELEASE STATEMENT

(Medical and Liability Release)

I understand that in the event medical intervention is needed for my child, every attempt will be made to contact immediately the emergency contacts listed on this form. In the event the emergency contacts cannot be reached in an emergency during the activity dates shown on this form, I hereby give my permission to the physician or dentist selected by the activity leader to hospitalize, to secure medical treatment and/or to order an injection, anesthesia, or surgery for my child as deemed necessary.

I understand that my insurance or my family's insurance coverage will be used, as primary coverage in the event medical intervention is needed. Coverage by the Greek Orthodox Church of Greater Salt Lake through its accident policy will be used as a backup for what my insurance or my family's insurance coverage does not cover.

(Acknowledgement of Risks)

I understand all reasonable safety precautions will be taken at all times by the Greek Orthodox Church of Greater Salt Lake and its agents during the events and activities in which my child participates. I understand the possibility of unforeseen hazards and know the inherent possibility of risk. I am aware that the Event entails risks of injury or death to my child. **I UNDERSTAND THAT THERE IS ALWAYS AN ELEMENT OF RISK, INCLUDING BUT NOT LIMITED TO, RISKS DUE TO THE NATURE OF THIS EVENT AND WEATHER CONDITIONS.** I understand the description of these risks is not complete and that other unknown or unanticipated risks may result in injury or death to my child. I agree to assume responsibility on behalf of my child for the risks identified herein and those risks not specifically identified. My child's participation in this activity is purely voluntary, no one is forcing my child to participate, and I elect to allow my child to participate in spite of the risks. Therefore, I agree to release and hold harmless the Greek Orthodox Church of Greater Salt Lake, its leaders, employees, and volunteer staff liable and the Wolf Creek Ranch home owners association, its owners and members for any and all damages, losses, diseases, or injuries incurred by my child.

I understand all reasonable safety precautions will be taken at all times by the Greek Orthodox Church of Greater Salt Lake and its agents during the events and activities. I understand the possibility of unforeseen hazards and know the inherent possibility of risk. I certify that my child is fully capable of participating in this activity. I agree to release and hold harmless, on behalf of my child, the Greek Orthodox Church of Greater Salt Lake, its leaders, employees, and volunteer staff and the Wolf Creek Ranch home owners association, its owners and members for any and all bodily injury, death, loss of personal property, damages, losses, diseases, or injuries, and expenses thereof as a result of the risks and dangers and of my child's negligence in participating in this activity.

(Consent to use of Images)

I consent to the use of any video images, photographs, audio recordings, or any other visual or audio reproduction of my child that may be taken of me during the activity/event to be used, distributed, or shown as the Greek Orthodox Church of Greater Salt Lake sees fit.

(Covenant Not to Sue)

I agree, on behalf of my child, not to sue or take any other civil or administrative action against the Greek Orthodox Church of Greater Salt Lake and the Wolf Creek Ranch home owners association, its owners and members for any and all civil liability or reimbursement of fees or costs with respect to the Event.

(Conduct)

All campers are expected to act in ways appropriate to an Orthodox Christian setting. While disciplinary action will be taken to resolve situations on site, the Camp Director (Priest/s) reserves the right to dismiss campers for gross violations of camp rules. Campers will be sent home, if necessary, and even in the middle of the night.

By signing below, I affirm that I have read and understand all of the information contained in this document and hereby agree to allow my child to participate in the Event on the terms described herein.
